- Training is provided through external agencies which has been more beneficial to the students.
- Curriculum enhancement, whenever required and wherever possible is done by conducting the Board of Studies meeting of the departments, once in every six months.
- Students are provided with On-Duty to attend Internships and the Tie-up of the institution with Internshala has provided the students to get stipend during their internship period.
