### *SUMMARY, SUGGESTIONS AND ACTION TAKEN REPORT OF THE STUDENT FEEDBACK – 2022-23*

As per the feedbacks received from the students, the major points were presented as a summary below:

- 1) Provisions of new courses in the curriculum suiting the needs of the industry.
- 2) Provisions of inter-disciplinary courses and focus on latest technological advancements, attracting placements.
- 3) Enhancement of delivery of courses with use of ICT tools for understanding the concept beyond the academic box.
- 4) Provisions of publications of results of every internal assessment.
- 5) Clear understanding on the activity assessment using Quiz or seminar or assignments.
- 6) Provisions to permit students with on duty to attend internships, participate in technical contests etc.,
- 7) Provisions to conduct value added courses with credits in the curriculum.

- 8) Exposure to advanced equipment's and technological advances to enhance the growth of research.
- 9) To conduct any kind of lectures, seminars or workshops through experts from industry.
- 10) To facilitate more core companies for placement,

#### SUGGESTIONS:

- 1) The students suggested for inter-disciplinary and integrated courses suiting to students and adapting them to the requirements of the industry for better placements.
- 2) The students suggested to include the courses in the curriculum and to enrich the same.
- 3) The students suggested for more usage of ICT tools in presentation of the concepts for better understanding of the practical concepts beyond the academic box.
- 4) The students suggested to share the assessment marks at the end of the each internal assessment for them to know their status.
- 5) The students suggested for a fair and just understanding of the activity based assessments which includes Quiz, seminars, assignments etc.,
- 6) The students suggested for industrial visits outside the state and companies that are related to their field of study.
- 7) The students suggested to provide On-Duty to attend internships and also to consider on duty in case the company permits and provides the extension period

in internship during the semester holidays and up to the start of the semester classes.

- 8) The students suggested to conduct value added courses with credit points and suggested to include the same in the curriculum which would enhance their resume at the time of placements.
- 9) The students suggested to bring-in more core companies for placement.
- 10) The students suggested to permit them to participate in technical contests in and around with on duty facility.

#### **ACTION TAKEN:**

- 1) Departments as per the suggestions discussed in the meeting with the Board of Studies, implemented with approval, courses with inter-disciplinary and integrated courses suiting to students and adapting them to the requirements of the industry for better placements.
- 2) Curriculum enhancement, whenever required and wherever possible is done by conducting the Board of Studies meeting of the departments, once in every six months.
- 3) Based on the suggestions received, more core companies were facilitated and the percentage of core companies have increased to 65% this year compared to 55% of last year.
- 4) To increase placements and make students placement-ready, training is provided through external agencies which has been more beneficial to the students.
- 5) Value-added courses are conducted by all the departments and it is also ensured that one value-added course is mandatorily conducted by every department in a

semester and students attend it without fail. Assessment is conducted at the end of the course and it is also ensured that students participate with full passion and successfully complete the course.

- 6) The institution has initiated more MoUs and with core industries for all the departments that not only increases the room for placements, internships etc., but also using such MoUs, it was suggested to develop more interaction for the students from the industry.
- 7) The students were encouraged to participate in more innovative and technical contests and the institution has also increased its focus in promoting innovative activities among the students and developing products that are suiting the industry needs.
- 8) As requested by the students to permit them to participate in competitions outside the state, students are provided on-duty with TA & DA to participate in events within the state and outside the state. Technical or Non-Technical, Co-curricular or Extra-curricular, students are encouraged to participate in such events and the institution supports the students with on-duty with TA & DA, for the students to participate in events within the state and outside the state.
- 9) The institution, as a policy matter has decided to conduct Guest lectures/Workshops using experts from the industry. Workshops are conducted across all departments and experts from the industry are invited as resource person.
- 10) Students are provided with On-Duty to attend Internships and the Tie-up of the institution with many industries across the globe, has provided the students to get stipend during their internship period.
